## **ORDINANCE NO. 02024-2**

AN ORDINANCE OF THE CITY OF WILDWOOD FLORIDA; AMENDING THE LAND DEVELOPMENT REGULATIONS OF THE CITY OF WILDWOOD, FLORIDA; PROVIDING FOR CODIFICATION IN THE LAND DEVELOPMENT REGULATIONS; PROVIDING FINDINGS AND INTENT; PROVIDING FOR CONFLICT AND SEVERABILITY; PROVIDING FOR AN EFFECTIVE DATE.

**SECTION 2. CODIFICATION.** Codification of this Ordinance in the Code of Ordinances of the City of Wildwood is authorized and directed.

**SECTION 3. CONFLICT**. All ordinances or parts of ordinances in conflict herewith, be, and the same are hereby repealed.

**SECTION 4. SEVERABILITY.** If any section, sentence, clause, or phrase of this Ordinance is held to be invalid or unconstitutional by a Court or competent jurisdiction, then said holding shall in no away effect the validity of the remaining portions of said Ordinance.

**SECTION 5. EFFECTIVE DATE.** This Ordinance shall be effective upon adoption during the second and final reading by the City of Wildwood City Commission.
