#### **ORDINANCE NO. 02023-59**

AN ORDINANCE OF THE CITY OF WILDWOOD FLORIDA, DECLARING CERTAIN REAL PROPERTY AS SURPLUS; DESIGNATING CERTAIN REAL PROPERTY AS ESSENTIAL TO THE CITY; GRANTING THE CITY MANAGER CERTAIN AUTHORIZATIONS AND DIRECTIONS; PROVIDING FOR FINDINGS; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Wildwood presently owns numerous parcels of real property; and

**WHEREAS**, the City of Wildwood currently uses or anticipates the future use of certain properties to serve vital government functions; and

**WHEREAS**, the City Commission of the City of Wildwood also desires to declare certain real property as surplus to the needs of the City; and

**WHEREAS**, the City Commission desires to clarify the record with respect to which properties are surplus by adopting an ordinance that supersedes any prior ordinances or resolutions declaring certain properties as surplus; and

WHEREAS, City Staff has reviewed the inventory of all City-owned property, and has determined that the City owns several properties that are being used by the City or will likely be used by the City in the future; and

**WHEREAS,** City Staff has reviewed the inventory of all City-owned property, and has determined that the City owns several properties that are appropriate to be declared as surplus property; and

WHEREAS, pursuant to City Staff's review of the inventory of City-owned property, the City Commission accepts City Staff's review, and hereby finds that Exhibit "A" attached hereto is sufficient to identify the City's surplus properties; and

WHEREAS, pursuant to City Staff's review of the inventory of all City-owned property, the City Commission accepts City Staff's review, and hereby finds that Exhibit "B" attached hereto is sufficient to identify all of the properties that are either currently being utilized for existing government uses or properties earmarked for future governmental usage; and

- **NOW, THEREFORE, BE IT ENACTED AND ORDAINED** by the City Commission of the City of Wildwood, Florida, as follows:
- **SECTION 1.** Recitals Adopted. The above recitals are hereby confirmed and adopted herein.
- **SECTION 2.** The property listed on Exhibit "A" is hereby declared surplus and is hereby approved for disposal.
- **SECTION 3.** The City Manager is authorized to dispose of the property listed on Exhibit "A" through any appropriate means, including, but not limited to, public auction, sale, donation to a non-profit organization, trade, or transfer to other governmental agency.
- **SECTION 4.** The property listed on Exhibit "B" is hereby declared to be vital to the governmental functions of the City and is found to be either currently utilized for existing government operations or earmarked for future governmental usage to serve vital functions of the City.
- **SECTION 5.** The City Manager is directed to continue to manage and preserve the property listed on Exhibit "B", so as to ensure that the vital functions of the City are able to be carried out.
- **SECTION 6.** Any surplus property that is appropriate for use as affordable housing as contemplated by Section 166.0451 of the Florida Statutes will be listed in a resolution subsequently adopted by the City Commission in compliance with said statute.
- **SECTION 7.** The City Manager is hereby authorized to do all things necessary to carry out the aims of this Ordinance.
- **SECTION 8.** Any future updates to Exhibits "A" or "B" as attached hereto may be done by ordinance or resolution as deemed appropriate by the City Manager.
- **SECTION 9.** If any section, subsection, sentence, clause, phrase, or portion of this Ordinance, or application hereof, is for any reason held invalid or unconstitutional by any Court, such portion or application shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions or application hereof.
- **SECTION 10.** That all prior Ordinances or Resolutions, or parts thereof, made in conflict with this Ordinance are hereby repealed.
- **SECTION 11.** This Ordinance shall become effective immediately upon its adoption.
