NOTICE IS HEREBY GIVEN that the City of Wildwood will receive sealed bids for the construction of the **CR 501 WTP IRON FILTER IMPROVEMENTS**. All contractors licensed by the State of Florida are hereby invited to submit a bid on the above-referenced project. Bids will be received until **2:00 PM**, E.S.T., on **June 20, 2024**, at the **City of Wildwood, City Hall, 100 N. Main Street, Wildwood, Florida 34785**. **DESCRIPTION OF WORK:** All work for the Project shall be constructed in accordance with the Drawings and Specifications prepared by the Engineer. Bids shall be submitted for furnishing, delivering, and installing all materials, equipment, and services, including labor for the Work, which generally involves the following activities:

Treatment improvements to the CR 501 WTP in Wildwood, FL. The improvements include the installation of two green sand filters, a new sodium hypochlorite chlorination and oxidation system, static mixer, a new corrosion inhibitor system, all associated site piping, required electrical upgrades, and required instrumentation, programming, and SCADA integration.

**CONTRACT TIME:** Construction time to achieve Substantial Completion is 270 consecutive calendar days from the date of the Notice to Proceed, with an additional 60 consecutive calendar days to achieve Final Completion. Total construction duration is 330 days.

All bids shall be prepared using the Project Manual and Drawings. Addenda will be sent via e-mail to all plan holders up to seventy-two (72) hours before the Bid closing time. The Owner/Engineer is not responsible for delivering addenda to prospective bidders.

**PRE-BID CONFERENCE:** A **non-mandatory** pre-bid conference will be held for this project at **10:00 AM** on **May 30, 2024**, at the City of Wildwood, 100 North Main Street, Wildwood, Florida 34785. A representative of the prime contractor should attend this meeting. Further information regarding the pre-bid conference is contained in Article 6 of Section 00100, Instructions to Bidders.

**BID SECURITY:** A 5% bid security is required for this project, to be submitted with bids.

**PERFORMANCE AND PAYMENT BOND:** The Owner will require that the Contractor furnish a Performance and Payment Bond in an amount equal to 100% of the Contract Price. All Payment and Performance Bonds shall be secured from or countersigned by an agency or surety company recognized in good standing and authorized to do business in the State of Florida.
